Capital Markets Overview

Introduction

- In the second quarter, equity performance in the United States continued its upward climb. The primary driver of the rally was ongoing monetary stimulus by major central banks throughout the world. Investor enthusiasm was also bolstered by the Federal Reserve's (the "Fed") indication that short-term interest rates could remain in their current low range for some time after Quantitative Ease 3 (QE3) tapering is complete. (QE3 allows the Fed to purchase billions of dollars in mortgage-backed securities to lower long-term interest rates and stimulate housing and other sectors dependent on borrowing.)
- The Dow Jones Industrial Average rose 2.8% in the second quarter. The NASDAQ Composite advanced 5.3% for the quarter. The S&P 500 rose 5.2% for the quarter, its sixth consecutive quarterly increase.
- All 10 sectors of the S&P 500 advanced in the second quarter. Energy fared the best, with an 11.5% uptick. Utilities rose 7.8% and Information Technology advanced 6.5%. The laggards were Consumer Discretionary, which rose 3.5%, and Financials, which advanced 2.3%.
- Morgan Stanley and Co. LLC economists expect that U.S. real GDP will be 2.1% in 2014 and 2.8% in 2015. Morgan Stanley economists forecast global GDP growth to be 3.2% in 2014 and 3.7% in 2015.
- In the second quarter, commodities rose modestly; the Bloomberg Commodity Index advanced 0.1%. For the quarter, gold rose 3.0%.
- For the second quarter, global mergers-and-acquisitions deal volume was \$935 billion, compared to \$495 billion for the second quarter of 2013. Global M&A activity increased to \$2.3 trillion in 2013 from \$2.2 trillion in 2012.

The U.S. Economy

- The Department of Commerce estimated that Gross Domestic Product decreased at an annual rate of 2.9% in the first quarter of 2014, in comparison to a 2.6% increase in the fourth quarter of 2013. Morgan Stanley and Co. LLC economists forecast that U.S. real GDP will be 2.1% in 2014 and 2.8% in 2015.
- For the quarter, the seasonally adjusted unemployment rate fell from 6.3% for both April and May to 6.1% for June. Job gains in the quarter took place in retail trade, health care, professional and business services, and food services and drinking places. The unemployment rate (6.1%) and the number of unemployed persons (9.5 million) decreased in June. The number of long-term unemployed (3.1 million) declined in June.
- According to the most recent estimate from the Bureau of Economic Analysis, corporate profits fell 9.1% between the fourth quarter of 2013 and the first quarter of 2014, and fell 2.2% between the first quarter of 2013 and the first quarter of 2014.
- Inflation remained low in the U.S. According to the Bureau of Labor Statistics, the seasonally adjusted Consumer Price Index rose 0.3% in April and 0.4% in May. Morgan Stanley & Co. LLC economists forecast a 1.9% inflation rate for 2014 and 1.7% for 2015.
- The Census Bureau reported that private-sector housing starts in May 2014 were at a seasonally adjusted annual rate of 1,001,000—9.4% above May 2013 housing starts. The rise in housing starts over the past year indicates that despite some recent setbacks, the housing market is steadily rebounding.
- The Census Bureau also reported that seasonally adjusted retail and food services sales increased 0.3% between April and May 2014, and increased 4.3% between May 2013 and May 2014.
- In June, the Institute for Supply Management's Purchasing Managers' Index (PMI), a manufacturing-sector index, was 55.3, down 0.1 from May, and up from April's 54.9. The latest PMI data indicates an expansion in the manufacturing sector for 13 consecutive months. Overall, PMI has been above 43 for 61 consecutive months. Generally speaking, a PMI or NMI (ISM Non-Manufacturing Index) over 50 indicates that the sector is expanding and a PMI over 43 indicates that the overall economy is expanding.
- The NMI rose 1.1 points to 56.3 between April and May of 2014, and fell 0.3 to 56.0 between May and June of 2014. The index has now been above 50 for 53 consecutive months.

The U.S. Equity Markets

- The Dow Jones Industrial Average rose 2.8% in the second quarter. The NASDAQ Composite advanced 5.3% for the quarter. The S&P 500 rose 5.2% for the quarter, its sixth consecutive quarterly increase.
- All 10 sectors of the S&P 500 advanced in the second quarter. Energy fared the best, with an 11.5% uptick. Utilities rose 7.8% and Information Technology advanced 6.5%. The laggards were Consumer Discretionary, which rose 3.5%, and Financials, which advanced 2.3%.
- Both value- and growth-style stocks rose during the second quarter, with value stocks faring better among those of small- and mid-cap companies. The Russell Midcap Value Index climbed 5.6%, with the best quarterly showing of the Russell indices referenced here. The large-cap Russell 1000 Growth Index rose 5.1% for the quarter. The Russell 1000 Index, a large-cap index, rose 5.1% for the quarter. The Russell 1000 Value Index, a large-cap index, also rose 5.1% for the quarter.
- The Russell Midcap Index rose 5.0% for the quarter. The Russell Midcap Growth Index advanced 4.4% for the quarter. The Russell 2000 Value Index, a small-cap index, rose 2.4% for the quarter. The small-cap Russell 2000 Index advanced 2.0% for the quarter. The Russell 2000 Growth Index, a small-cap index, rose 1.7% for the quarter, but had the weakest showing of the quarter compared to the other Russell indices referenced here.
- Despite geopolitical risks in Iraq and Ukraine and investor caution over the winding down of the Fed's QE3 stimulus, the CBOE Volatility Index (VIX), the so-called "fear index," fell to 11.6 at the end of the second quarter. Moreover, the index hit a seven-year low of 10.6 on June 18. The index's second-quarter calm is a distinct contrast from its August 8, 2011 high of 48.

Global Equity Markets

- In the second quarter, emerging markets (EM) and global equities advanced. The MSCI EAFE Index (a benchmark for developed markets) rose 4.3% for U.S.-currency investors and 3.7% for local-currency investors, as the U.S. dollar depreciated in relation to the currencies of many nations in the index. In contrast, in the first quarter of 2014, the MSCI EAFE Index rose 0.8% in U.S. dollar terms and fell 0.2% in local currency terms.
- For the second quarter, the MSCI Emerging Markets Index advanced 6.7% for U.S.-currency investors and 5.3% for local-currency investors, as the U.S. dollar depreciated in relation to many emerging-market currencies. This contrasts with the previous quarter, when the MSCI Emerging Markets Index declined 0.4% for U.S.-dollar-based investors and fell 0.5% for local-currency investors.
- The MSCI Europe Index rose 3.7% for U.S.-currency investors and 3.4% for local-currency investors during the second quarter. In comparison, the MSCI Far East Index advanced 6.8% for the quarter in terms of the U.S. dollar and 5.3% in terms of local currencies.
- More specific emerging economy equity market indices rose in the second quarter. The MSCI BRIC (Brazil, Russia, India and China) Index climbed 8.0% for the quarter in U.S. dollar terms and 7.0% in terms of local currencies. In comparison, for the second quarter, the MSCI EM Asia Index advanced 7.3% in U.S. dollar terms and 5.6% in local terms.

The U.S. Bond Market

- In the second quarter, the bond market extended the gains of the first quarter of 2014—the Barclays U.S. Aggregate Bond Index, a general measure of the bond market, increased 2.0% for the quarter. Interest rates declined during the second quarter, as the yield on the 10-Year U.S. Treasury note fell to a quarter-end 2.51% from 2.76% at the end of the first quarter.
- Also in the second quarter, riskier parts of the bond market, including high-yield debt and corporate credit, built upon their first quarter 2014 upswing. As a result, the Barclays Capital High Yield Index, a measure of lower-rated corporate bonds, advanced 2.4% for the quarter.
- Investors continued to return to mortgage-backed securities in the second quarter. Consequently, the Barclays Capital Mortgage Backed Index rose 2.4% for the quarter.
- During the second quarter, investors embraced the municipal-bond market. As a result, the Barclays Capital Muni Index rose 2.6% for the quarter.

INDEX DESCRIPTIONS:

DOW JONES INDUSTRIAL AVERAGE: The most widely used indicator of the overall condition of the stock market, a price-weighted average of 30 actively traded blue-chip stocks, primarily industrials. The 30 stocks are chosen by the editors of The Wall Street Journal (WSJ) (which is published by Dow Jones & Company), a practice that dates back to the beginning of the century. Charles Dow officially started the Dow in 1896, at which time it consisted of only 11 stocks. The Dow is computed using a price-weighted indexing system, rather than the more common market cap-weighted indexing system. Simply put, the editors at WSJ add up the prices of all the stocks and then divide by the number of stocks in the index. (In actuality, the divisor is much higher today in order to account for stock splits that have occurred in the past.) **BLOOMBERG COMMODITY INDEX:** Composed of futures contracts on physical commodities which are traded on U.S. exchanges, with the exception of aluminum, nickel and zinc, which trade on the London Metal Exchange (LME). **NASDAQ COMPOSITE INDEX:** Covers 4,500 stocks traded over the counter. It represents many small company stocks but is heavily influenced by about 100 of the largest NASDAQ stocks. It is a value-weighted index calculated on price change only and does not include income. **S&P 500 INDEX:** Covers 400 industrial, 40 utility, 20 transportation and 40 financial companies in the U.S. markets (mostly NYSE issues). The index represents about 75% of NYSE market cap and 30% of NYSE issues. It is a capitalization-weighted index calculated on a total-return basis with dividends reinvested. **RUSSELL 1000 INDEX:** Measures the performance of the 1,000 largest companies in the Russell 3000 Index, which represents approximately 89% of the total market capitalization of the Russell 3000 Index. As of the latest reconstitution, the average market capitalization was approximately \$9.9 billion; the median market capitalization was approximately \$3.7 billion. The smallest company in the index had an approximate market capitalization of \$1,404.7 million. **RUSSELL 1000 GROWTH INDEX:** Measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values. **RUSSELL 1000 VALUE INDEX:** Measures the performance of those Russell 1000 companies with lower price-to-book ratios and lower forecasted growth values. **RUSSELL 2000 INDEX:** Measures the performance of the 2,000 smallest companies in the Russell 3000 Index, which represents approximately 11% of the total market capitalization of the Russell 3000 Index. As of the latest reconstitution, the average market capitalization was approximately \$592.0 million; the median market capitalization was approximately \$500.0 million. CONSUMER PRICE INDEX (CPI) includes monthly data on changes in the prices paid by urban consumers for a representative basket of goods and services.

CBOE VOLATILITY INDEX: The CBOE Volatility Index—more commonly referred to as “VIX”—is an up-to-the-minute market estimate of expected volatility that is calculated by using real-time S&P 500[®] Index (SPX) option bid/ask quotes. VIX uses nearby and second nearby options with at least eight days left to expiration and then weights them to yield a constant, 30-day measure of the expected volatility of the S&P 500 Index.




SECOND QUARTER 2014

Introduction

- In the second quarter, equity performance in the United States continued its upward climb. The primary driver of the rally was ongoing monetary stimulus by major central banks throughout the world. Investor enthusiasm was also bolstered by the Federal Reserve's (the "Fed") indication that short-term interest rates could remain in their current low range for some time after Quantitative Ease 3 (QE3) tapering is complete. (QE3 allows the Fed to purchase billions of dollars in mortgage-backed securities to lower long-term interest rates and stimulate housing and other sectors dependent on borrowing.)
- The Dow Jones Industrial Average rose 2.8% in the second quarter. The NASDAQ Composite advanced 5.3% for the quarter. The S&P 500 rose 5.2% for the quarter, its sixth consecutive quarterly increase.
- All 10 sectors of the S&P 500 advanced in the second quarter. Energy fared the best, with an 11.5% uptick. Utilities rose 7.8% and Information Technology advanced 6.5%. The laggards were Consumer Discretionary, which rose 3.5%, and Financials, which advanced 2.3%.
- Morgan Stanley and Co. LLC economists expect that U.S. real GDP will be 2.1% in 2014 and 2.8% in 2015. Morgan Stanley economists forecast global GDP growth to be 3.2% in 2014 and 3.7% in 2015.
- In the second quarter, commodities rose modestly; the Bloomberg Commodity Index advanced 0.1%. For the quarter, gold rose 3.0%.
- For the second quarter, global mergers-and-acquisitions deal volume was \$935 billion, compared to \$495 billion for the second quarter of 2013. Global M&A activity increased to \$2.3 trillion in 2013 from \$2.2 trillion in 2012.


The U.S. Economy

The Department of Commerce estimated that Gross Domestic Product decreased at an annual rate of 2.9% in the first quarter of 2014, in comparison to a 2.6% increase in the fourth quarter of 2013. Morgan Stanley and Co. LLC economists forecast that U.S. real GDP will be 2.1% in 2014 and 2.8% in 2015.

For the quarter, the seasonally adjusted unemployment rate fell from 6.3% for both April and May to 6.1% for June. Job gains in the quarter took place in retail trade, health care, professional and business services, and food services and drinking places. The unemployment rate (6.1%) and the number of unemployed persons (9.5 million) decreased in June. The number of long-term unemployed (3.1 million) declined in June.

According to the most recent estimate from the Bureau of Economic Analysis, corporate profits fell 9.1% between the fourth quarter of 2013 and the first quarter of 2014, and fell 2.2% between the first quarter of 2013 and the first quarter of 2014.

Inflation remained low in the U.S. According to the Bureau of Labor Statistics, the seasonally adjusted Consumer Price Index rose 0.3% in April and 0.4% in May. Morgan Stanley & Co. LLC economists forecast a 1.9% inflation rate for 2014 and 1.7% for 2015.

The Census Bureau reported that private-sector housing starts in May 2014 were at a seasonally adjusted annual rate of 1,001,000—9.4% above May 2013 housing starts. The rise in housing starts over the past year indicates that despite some recent setbacks, the housing market is steadily rebounding.

The Census Bureau also reported that seasonally adjusted retail and food services sales increased 0.3% between April and May 2014, and increased 4.3% between May 2013 and May 2014.

In June, the Institute for Supply Management's Purchasing Managers' Index (PMI), a manufacturing-sector index, was 55.3, down 0.1 from May, and up from April's 54.9. The latest PMI data indicates an expansion in the manufacturing sector for 13 consecutive months. Overall, PMI has been above 43 for 61 consecutive months. Generally speaking, a PMI or NMI (ISM Non-Manufacturing Index) over 50 indicates that the sector is expanding and a PMI over 43 indicates that the overall economy is expanding.


The NMI rose 1.1 points to 56.3 between April and May of 2014, and fell 0.3 to 56.0 between May and June of 2014. The index has now been above 50 for 53 consecutive months.

U.S. Equity Markets

The Dow Jones Industrial Average fell 0.2% in the first quarter. The NASDAQ Composite advanced 0.8% for the quarter. The S&P 500 rose 1.8% for the quarter, its fifth consecutive quarterly increase.

Nine of the 10 sectors of the S&P 500 advanced in the first quarter. Utilities fared the best, with a 10.1% uptick. Health Care rose 5.8% and Materials advanced 2.9%. The laggards were Industrials, which advanced 0.1%, and Consumer Discretionary, which fell 2.8%.

Both value- and growth-style stocks rose during the second quarter, with value stocks faring better among those of small- and mid-cap companies. The Russell Midcap Value Index climbed 5.6%, with the best quarterly showing of the Russell indices referenced here. The large-cap Russell 1000 Growth Index rose 5.1% for the quarter. The Russell 1000 Index, a large-cap index, rose 5.1% for the quarter. The Russell 1000 Value Index, a large-cap index, also rose 5.1% for the quarter.

The Russell Midcap Index rose 5.0% for the quarter. The Russell Midcap Growth Index advanced 4.4% for the quarter. The Russell 2000 Value Index, a small-cap index, rose 2.4% for the quarter. The small-cap Russell 2000 Index advanced 2.0% for the quarter. The Russell 2000 Growth Index, a small-cap index, rose 1.7% for the quarter, but had the weakest showing of the quarter compared to the other Russell indices referenced here.

Despite geopolitical risks in Iraq and Ukraine and investor caution over the winding down of the Fed’s QE3 stimulus, the CBOE Volatility Index (VIX), the so-called “fear index,” fell to 11.6 at the end of the second quarter. Moreover, the index hit a seven-year low of 10.6 on June 18. The index’s second-quarter calm is a distinct contrast from its August 8, 2011 high of 48.


Global Equity Markets

In the second quarter, emerging markets (EM) and global equities advanced. The MSCI EAFE Index (a benchmark for developed markets) rose 4.3% for U.S.-currency investors and 3.7% for local-currency investors, as the U.S. dollar depreciated in relation to the currencies of many nations in the index. In contrast, in the first quarter of 2014, the MSCI EAFE Index rose 0.8% in U.S. dollar terms and fell 0.2% in local currency terms.

For the second quarter, the MSCI Emerging Markets Index advanced 6.7% for U.S.-currency investors and 5.3% for local-currency investors, as the U.S. dollar depreciated in relation to many emerging-market currencies. This contrasts with the previous quarter, when the MSCI Emerging Markets Index declined 0.4% for U.S.-dollar-based investors and fell 0.5% for local-currency investors.

The MSCI Europe Index rose 2.2% for U.S.-currency investors and 1.9% for local currency investors during the first quarter. In comparison, the MSCI Far East Index fell 5.0% for the quarter in terms of the U.S. dollar and declined 6.6% in terms of local currencies.

More specific emerging economy equity market indices rose in the second quarter. The MSCI BRIC (Brazil, Russia, India and China) Index climbed 8.0% for the quarter in U.S. dollar terms and 7.0% in terms of local currencies. In comparison, for the second quarter, the MSCI EM Asia Index advanced 7.3% in U.S. dollar terms and 5.6% in local terms.


The U.S. Bond Market

In the second quarter, the bond market extended the gains of the first quarter of 2014—the Barclays U.S. Aggregate Bond Index, a general measure of the bond market, increased 2.0% for the quarter. Interest rates declined during the second quarter, as the yield on the 10-Year U.S. Treasury note fell to a quarter-end 2.51% from 2.76% at the end of the first quarter.

Also in the second quarter, riskier parts of the bond market, including high-yield debt and corporate credit, built upon their first quarter 2014 upswing. As a result, the Barclays Capital High Yield Index, a measure of lower-rated corporate bonds, advanced 2.4% for the quarter.

Investors continued to return to mortgage-backed securities in the second quarter. Consequently, the Barclays Capital Mortgage Backed Index rose 2.4% for the quarter.

During the second quarter, investors embraced the municipal-bond market. As a result, the Barclays Capital Muni Index rose 2.6% for the quarter.

INDEX DESCRIPTIONS

DOW JONES INDUSTRIAL AVERAGE: The most widely used indicator of the overall condition of the stock market, a price-weighted average of 30 actively traded blue-chip stocks, primarily industrials. The 30 stocks are chosen by the editors of The Wall Street Journal (WSJ) (published by Dow Jones & Company), a practice that dates back to the beginning of the century. Charles Dow officially started the Dow in 1896, at which time it consisted of only 11 stocks. The Dow is computed using a price-weighted indexing system, rather than the more common market-cap-weighted indexing system. Simply put, the editors at WSJ add up the prices of all the stocks and then divide by the number of stocks in the index. (In actuality, the divisor is much higher today in order to account for stock splits that have occurred in the past.)

STANDARD & POOR'S 500 Index: Covers 400 industrial, 40 utility, 20 transportation and 40 financial companies in the U.S. markets (mostly NYSE issues). The index represents about 75% of NYSE market cap and 30% of NYSE issues. It is a capitalization-weighted index calculated on a total return basis with dividends reinvested. **NASDAQ COMPOSITE Index:** Covers 4,500 stocks traded over the counter. It represents many small company stocks but is heavily influenced by about 100 of the largest NASDAQ stocks. It is a value-weighted index calculated on price change only and does not include income. **BLOOMBERG COMMODITY Index:** Composed of futures contracts on physical commodities which are traded on U.S. exchanges, with the exception of aluminum, nickel and zinc, which trade on the London Metal Exchange (LME). **VIX Index** (Chicago Board Options Exchange Volatility Index): Estimates volatility in the S&P 500 Index for the next 30 days using a weighted blend of prices for various options on the S&P.

RUSSELL 1000 Index: Measures the performance of the large-cap segment of the U.S. equity universe. It is a subset of the Russell 3000 Index and includes approximately 1,000 of the largest securities based on a combination of their market cap and current index membership. The Russell 1000 represents approximately 92% of the U.S. market. **RUSSELL 1000 GROWTH Index:** Measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values. **RUSSELL 1000 VALUE Index:** Measures the performance of those Russell 1000 companies with lower price-to-book ratios and lower forecasted growth values. **RUSSELL 2000 Index:** Measures the performance of the small-cap segment of the U.S. equity universe. The Russell 2000 Index is a subset of the Russell 3000 Index and represents approximately 10% of the total market capitalization of that index. It includes approximately 2,000 of the smallest securities based on a combination of their market cap and current index membership. **RUSSELL 2000 GROWTH Index:** Measures the performance of those Russell 2000 companies with higher price-to-book ratios and higher forecasted growth values. **RUSSELL 2000 VALUE Index:** Measures the performance of those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. **RUSSELL MIDCAP Index:** Measures the performance of the mid-cap segment of the U.S. equity universe. The Russell Midcap Index is a subset of the Russell 1000 Index. It includes approximately 800 of the smallest securities based on a combination of their market cap and current index membership. The Russell Midcap Index represents approximately 31% of the total market capitalization of the Russell 1000. **RUSSELL MIDCAP GROWTH Index:** Measures the performance of those Russell mid-cap companies with higher price-to-book ratios and higher forecasted growth rates. **RUSSELL MIDCAP VALUE Index:** Measures the performance of those Russell mid-cap companies with lower price-to-book ratios and lower forecasted growth values. **RUSSELL 3000 Index:** Measures the performance of the 3,000 largest U.S. companies based on total market capitalization, which represents approximately 98% of the investable U.S. equity market. **RUSSELL 3000 GROWTH Index:** Measures the performance of those Russell 3000 companies with higher price-to-book ratios and higher forecasted growth rates. **RUSSELL 3000 VALUE Index:** Measures the performance of those Russell mid-cap companies with lower price-to-book ratios and lower forecasted growth values.

Composed of all bonds covered by BARCLAYS CAPITAL GCB Index with maturities between 1 and 9.99 years. Total return comprises price appreciation/depreciation and income as a percent of the original investment. Indices are rebalanced monthly by market capitalization. **BARCLAYS CAPITAL LONG GOVERNMENT CREDIT Index:** Composed of all bonds covered by BARCLAYS CAPITAL GCB Index with maturities of 10 years or greater. Total return comprises price appreciation/depreciation and income as a percent of the original investment. Indices are rebalanced monthly by market capitalization. **BARCLAYS CAPITAL MORTGAGE BACKED SECURITIES Index:** Includes all fixed securities issued and backed by mortgage pools of Ginnie Mae (GNMA), Fannie Mae (FNMA), Freddie Mac (FHLMC) and half-coupon securities. 
Asset Allocation By Manager


Loss in Varying Time Periods (%)




Beta - Rolling Periods

MONTHLY Observations Since 07/2007 (w/Simple Linear Regression Line)












Loss in Varying Time Periods (%)


Loss in Varying Time Periods (%)






Beta - Rolling Periods

MONTHLY Observations Since 09/2003 (w/Simple Linear Regression Line)





Alpha

Alpha is the value added by active management of the portfolio's assets, given the risk of that portfolio. In other words, alpha is equal to the incremental return earned by the manager when the market is flat or stationary. An alpha of zero indicates that the manager earned the exact return dictated by the level of market risk (i.e., beta) of the portfolio. A positive alpha indicates that the manager has earned, on average, more than the portfolio's level of market risk would have dictated. A negative alpha indicates that the manager has earned, on average, less than the portfolio's level of market risk would have dictated. Alpha is the Y-intercept of the least squares regression line.

Beta

Beta is the systematic risk of the portfolio. Measured by the slope of the least squares regression, beta is the measure of portfolio risk which cannot be removed through diversification. Beta is also known as market risk. Beta is a statistical estimate of the average change in the portfolio's performance with a corresponding 1.0 percent change in the risk index. A beta of 1.0 indicates that the portfolio moves, on average, lock step with the risk index. A beta in excess of 1.0 indicates that the portfolio is highly sensitive to movements in the risk index. A beta of 1.5, for example, indicates that the portfolio tends to move 1.5 percent with every 1.0 percent movement in the risk index. A beta of less than 1.0 indicates that the portfolio is not as sensitive to movements in the risk index. A beta of 0.5, for example, indicates that the portfolio moves only 0.5 percent for every 1.0 percent movement in the risk index.

R-Squared

R-squared, or the coefficient of determination, measures the strength of the least squares regression relationship between the portfolio (the dependent variable) and the risk index (the independent variable). The statistic reveals the extent to which the variability in the dependent variable is due to the variability in the independent variable. As such, R-squared measures how well the portfolio returns move in tandem with the returns of the risk benchmark. Though it is true that the higher the R-squared the better, an R-squared of less than 0.9 (i.e., 90 percent), indicates that the total fund does not track closely with the risk benchmark. The strength of the R-squared statistic will reflect on the strength of alpha and beta. A weak R-squared, for example, would indicate that alpha and beta cannot be strictly interpreted.
