Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Police Officers' Pension Trust Fund account for the period ending September 30, 2014. Relevant indices have been included for comparison purposes.

At the September Federal Open Market Committee meeting, Chairwoman Janet Yellen repeated that the current target range for the fed funds rate will remain the same for "a considerable time" after completing asset purchases. However, the median expectation for fed funds target at year end 2015 increased 30 basis points to 1.375%, even while growth projections of GDP were reduced. The fear of a rate hike caused yields to jump up from their year-to-date lows, but geopolitical risks such as airstrikes in the Middle East, turmoil in the Ukraine, and protests in Hong Kong provide refuge demand for U.S. government debt.

After touching a low of 2.33%, a level not seen on the 10-year Treasury since June 2013, the yield ended the third quarter at 2.51%, unchanged from the previous quarter end. The two-year yield increased 13 basis points to 0.58%, while the 30-year Treasury yield dropped 13 basis points to 3.21%. These moves caused the 2-30 year yield spread to flatten to 263 basis points.

For the third quarter, the bond market delivered modest positive performance on the Barclays Capital Aggregate Index of 0.17%, while the Barclays Capital Intermediate Government Credit Index provided a slightly negative return of -0.03%. Spread product was out of favor as all four sectors delivered a negative excess return. Corporate bonds were hit hardest with an excess return of -74 basis points, followed by mortgage-backed securities with an excess return of -27 basis points. Agencies and asset-backed securities provided excess returns of -11 basis points and -5 basis points, respectively.

Our duration remains marginally longer than the benchmark index. We have significantly reduced our exposure to corporate bonds given the recent spread tightening and are now underweight versus the index. In the short term, we continue to believe rates will remain range bound with a bias lower.
