Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Police Officers' Pension Trust Fund for the period ending March 31, 2015. Relevant indices have been included for comparison purposes.

At the March FOMC meeting the word "patient" was removed from the policy statement, marking the end of six years of forward guidance. Although this change in language was initially thought by many to signal a more hawkish position from the Fed, their view on economic projections is deemed more meaningful to rates. On that note, the Fed downgraded its GDP expectations for the upcoming years, while lowering inflation expectations. Additionally, recent housing and manufacturing data have weakened, raising concerns over slowing growth at the same time analysts forecast the first contraction in quarterly profit for S&P 500 companies since 2009.

After dropping to a low of 1.67% then reaching a high of 2.24%, the 10-year Treasury yield ended the first quarter 24 basis points lower at 1.93%. The two-year yield declined 11 basis points to 0.55%, while the 30-year Treasury yield dropped 21 basis points to 2.54%. These moves caused the 2-30 year yield spread to flatten to 199 basis points.

Due to the decline in rates, the bond market delivered positive performance for the quarter with a return on the Barclays Capital Aggregate Index of 1.61% and a return on the Barclays Capital Intermediate Government Credit Index of 1.45%. Spread product was mixed as two out of four sectors delivered a positive excess return. Corporate bonds and asset-backed securities provided positive excess returns of 27 basis points and 14 basis points, respectively. Mortgage-backed securities and agencies underperformed delivering negative excess returns with -50 basis points and -3 basis points, respectively.

Our duration remains longer than the benchmark index, and we remain underweight corporate bonds versus the index. In the short term, we continue to believe rates will remain range bound with a bias lower.
