2nd Quarter 2015 Fixed Income Market Commentary

June 30, 2015

- The recent surge in bond yields probably surprised and disturbed many FOMC members, leading to more cautious projections and comments from the Committee at the June meeting relative to previous meetings. While a rate increase in 2015 is still possible, subsequent increases might be more gradual than markets had been assuming.
- In the economy, despite the solid increases in the pace of sales of single family homes and the best increase in consumer spending since 2009, inflation remains subdued. The recent reading of the Fed's preferred inflation measure, the core PCE deflator, showed a year-over-year increase of only 1.2%. Because inflation is still well below their target of 2%, most FOMC members believe the eventual rise in the fed funds rate can be very gradual.
- The 10-year Treasury yield increased 40 basis points to end the quarter at 2.33%. The two-year yield rose 8 basis points to 0.63%, while the 30-year Treasury yield increased 56 basis points to 3.11%. These moves caused the 2-30-year yield spread to steepen to 248 basis points.
- Due to the rise in rates, the bond market delivered negative performance for the quarter with a return on the Barclays Capital Aggregate Index of -1.68% and a return on the Barclays Capital Intermediate Government Credit Index of -0.62%.
- Spread product was mixed this quarter with three of the four sectors providing modest positive excess returns. Asset-backed securities were the leader with an excess return of 21 basis points, followed by agencies and mortgage-backed securities with excess returns of 19 basis points and 5 basis points, respectively. Corporate bonds disappointed this quarter with a negative excess return of -87 basis points.
- Our duration remains longer than the benchmark index, and we remain underweight corporate bonds versus the index. In the short term, we continue to believe rates will remain range bound with a bias lower.





