Market Review and Outlook

Review

It was an interesting ride for investors during the second quarter of 2015 with an excellent month of May sandwiched in between two volatile months of April and June, resulting in most domestic stock indices delivering slight gains for Q2. During Q2, the realization that the U.S. economy appeared to have hit a soft patch in Q1 (restrained by an unusually harsh winter across much of the Midwest and Northeast and accompanied by a prolonged stoppage at West Coast ports) resulted in Q1 2015 GDP output decreasing at a 0.7% annualized rate. The slowdown in the U.S. economy brought into question whether there exhibited sufficient strength to allow the Federal Reserve Board (the "Fed") to end its easy monetary policy and turn its attention to its first interest rate increase in nearly a decade.

For most of 2015, the market has been volatile. Inflation and interest rates began to rise along with the price of oil. Even though there continues to be a dilemma in Greece and its standoff with European creditors, the massive monetary stimulus launched by the European Central Bank in early 2015 is showing signs of promoting growth in the Eurozone as well as economies dependent on global trade. Also after being adrift for several years, Chinese policymakers created financial market conditions which erupted the Chinese stock market to the upside which may prove to be unhealthy and volatile. With many of the world's economies, currencies, central banks and interest rates on very diverse paths, the market movement was not consistent across sectors. Investors continued to wrestle with the implications of last year's dramatic collapse of oil prices, while the rapid ascent of the U.S. dollar put pressure on the earnings outlooks of many multinational firms. While these macroeconomic factors hurt sectors such as Energy, Materials and Industrials, the Health Care sector delivered very strong returns that far outpaced the rest of the market. The Health Care sector was powered by a vigorous mergers and acquisitions (M&A) environment, especially within the biotechnology and specialty pharmaceutical industries.

The Apex SMID Growth portfolio was up 3.83% for the quarter while the Russell 2500 Growth Index was up 0.60%. The index's performance was predominately driven by only two sectors posting positive returns - Health Care and Information Technology. These gains offset relative weakness in all other sectors with Industrials and Materials performing the worst in this environment. Our portfolio structure was solid during the period as we maintained our overweight in Health Care and Information Technology while being underweight in Industrials and Materials which collectively added approximately 70 basis points performance versus the Index. Our thematic focus performed well during the quarter with E-commerce positions such as Expedia and IAC/Interactive as well as Chinese social site YY performing well. During 2015 we continued to opportunistically position the technology holdings in high conviction areas of big data and analytics as well as cybersecurity with companies such as Tableau, FireEye, and Fortinet all up approximately 20% for the quarter. While our commitment to these high areas of growth added 250 basis points stock selection performance in Technology, our diverse Health Care holdings also performed admirably in this continued sizzling sector of the market. Two beneficiaries of the Affordable Care Act, Medicaid health care providers and hospitals, were well represented in the portfolio with Centene and Universal Health Services along with Enanta with its Hepatitis C drug and glucose monitoring system provider, DexCom all up double digits for the quarter.

Outlook

We believe the economic weakness noted in early 2015 will prove to be transient, and that economic growth will resume, fueled by low inflation, a benign interest rate environment, and improving consumer spending. Some of this strength is showing up in improving home prices, employment and consumer sentiment. We continue to have faith in the strength of the U.S. economy, as well as indications of an improving recovery in Europe. We would expect higher levels of volatility to continue, as the market perceives stocks to be expensive and earnings growth weak. With the rising U.S. dollar and the associated corresponding cheaper imports, we would anticipate inflation expectations to remain subdued, providing the Fed flexibility on when to raise rates.

At Apex, one of the foundations of our success is focusing on the long-term sustainability of secular growth trends. The performance dichotomy across sectors highlights the importance of sharpening the focus on those industries that are able to deliver sustained earnings growth within an uncertain economic backdrop. During challenging times, we remain committed to the opportunities provided in such areas as consumer mobility, big data & cloud computing, cybersecurity, the U.S. manufacturing renaissance, personalized medicine and genomics, and energy independence. Our commitment to these growth areas provides earnings sustainability, with an eye towards mitigating return volatility in a weakly sustaining U.S. economy, coupled with global growth anxieties, our focus will continue to be on selective opportunities that could benefit in this environment.

2nd Quarter Performance Drivers


Positive Impacts:

- Stock selection within technology, health care, consumer discretionary, energy and consumer staples contributed to relative performance.
- Within sector allocation the over-weight in technology and health care and the under-weight in materials contributed to relative performance.
- Top 5 individual stock contributors were: Universal Health Services (+23%), Expedia (+14%), Enanta Pharmaceuticals (+47%), IAC/InterActive (+19%) and Tableau Software (+25%)

Negative Impacts:

- Stock selection within materials and industrials detracted from relative performance.
- The 5 biggest individual detractors to performance were: KapStone Paper (-29%), Avis (-25%), Dillards (-23%), Medivation (-12%) a (-11%).
