Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Police Officers' Pension Trust Fund for the period ending September 30, 2015. Relevant indices have been included for comparison purposes.

For the 55th consecutive meeting, the FOMC voted to keep its overnight target rate unchanged at 0.00% to 0.25%. The decision was a bit of a surprise as approximately half of economists surveyed believed the Fed would go ahead with its first rate increase since 2006. In their official statement, the Committee conveyed that it wants to see "some further" improvement in the labor market and added a new concern about "recent global economic and financial developments" impacting economic activity and putting "downward pressure on inflation in the near term." Additionally, the FOMC lowered its projected path forward for interest rates. The median forecast for the 2015 year-end overnight rate was lowered from 0.625% to 0.375% implying just one rate hike this year. It would be surprising if there was enough improvement in the labor market and on the global stage to ease the Fed's concerns by the October meeting, so the December meeting appears to be a more likely candidate for liftoff at this point.

The 10-year Treasury yield declined 27 basis points to end the quarter at 2.06%. The 2-year yield rose 1 basis points to 0.64%, while the 30-year Treasury yield dropped 23 basis points to 2.88%. These moves caused the 2-30 year yield spread to flatten to 224 basis points.

With the decline in rates, the bond market delivered positive performance this quarter with a return on the Barclays Capital Aggregate Index of 1.23% and a return on the Barclays Capital Intermediate Government Credit Index of 0.95%. Spread product was mostly negative this month with only one of the four sectors posting a positive excess return. Asset-backed securities were the lone bright spot with an excess return of 16 basis points. The agency and corporate sectors were the worst performers this quarter with a negative excess return of -146 basis points for each sector. Mortgage-backed securities posted a modestly negative excess return of -22 basis points. Thus, the Barclays Capital Aggregate Index posted a negative excess return of -57 basis points for the quarter.

Our duration remains longer than the benchmark index, and we remain underweight corporate bonds versus the index. In the short term, we continue to believe rates will remain range bound with a bias lower.
