Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Firefighters' Pension Trust Fund for the period ending March 31, 2016. Relevant indices have been included for comparison purposes.

There has been quite a rebound in risk assets since mid-February. Forgotten and pushed aside are the concerns of a hard landing in China and slowing global economic growth which sent stocks lower and corporate bond spreads wider. The rebound has been on the back of central bank policy as the ECB expanded its asset purchase program, and the most recent statement from the FOMC has been interpreted by the market to be a dovish change in position. Not only did the Fed decide to hold rates steady this quarter, the number of expected hikes this year declined to only two after previously anticipating four as recently as December.

The yield of the 10-year Treasury declined 49 basis points to end the quarter at 1.78%. The 2-year yield decreased 32 basis points to 0.73% while the yield of the 30-year Treasury dropped 40 basis points to 2.62%. These moves caused the 2-30 year yield spread to flatten to 189 basis points.

With the decline in rates, the performance in the bond market was strong for the quarter with a return on the Barclays Capital Aggregate Index of 3.03% and a return on the Barclays Capital Intermediate Government Credit Index of 2.31%. Spread product was mixed this quarter with three of the four sectors posting a positive excess return. Agencies led the way with 23 basis points of excess return, followed by the corporate and asset backed securities sectors with 16 basis points excess return each. Mortgage backed securities underperformed with a negative excess return of -38 basis points. Thus, the excess return of the Barclays Capital Aggregate Index was a modest negative for the quarter with a return of -4 basis points.

Our duration remains longer than the benchmark index, and we remain underweight corporate bonds versus the index. In the short term, we continue to believe rates will remain range bound with a bias lower.
