Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Firefighters' Pension Trust Fund account for the period ending March 31, 2014. Relevant indices have been included for comparison purposes.

Following the March FOMC (Federal Open Market Committee) meeting, Federal Reserve Chairwoman Janet Yellen announced that the Fed would no longer be considering the unemployment rate as the sole barometer for when to start raising rates, and instead would consider a wide range of factors including labor market conditions, inflation expectations, and financial markets. She also hinted that the Fed could start raising rates as early as 6-months after the end of the bond buying program. The prospect of a rate hike in early 2015 spooked the market, causing an immediate shift to higher yields and a flattening of the yield curve. Later, Yellen qualified her earlier time frame statement with numerous other prerequisites and vowed to remain accommodative, citing "notable slack" in the job market.


The 10-year Treasury yield decreased 31 basis points in the first quarter to 2.72%. On the short end, the 2-year Treasury yield increased 5 basis points to 0.43%, the highest level since September 2013, while the 30-year Treasury yield dropped 41 basis points to 3.56%. These moves caused the 2 to 30-year yield spread to flatten to 313 basis points.

With the overall decline in rates, the bond market delivered positive performance for the quarter with a return on the Barclays Capital Aggregate Index of 1.84% and a return on the Barclays Capital Intermediate Government Credit Index of 1.00%. Spread product performed well as three out of four sectors delivered positive excess return. Corporate bonds were the leader with 70 basis points of excess return, followed by agencies and asset-backed securities with an excess return of 30 basis points and 19 basis points, respectively. Mortgage-backed securities lagged with a negative excess return of -24 basis points. Thus, the Barclays Capital Aggregate Index provided an excess return of 16 basis points this quarter.

Our duration remains marginally longer than the benchmark index and we continue to be overweight in corporate bonds with an emphasis on financials. However, we have somewhat reduced our exposure to corporate bonds given the recent spread tightening. In the short term, we believe rates will trade in a range with a bias lower.
