Planning

- The Florida Department of Environmental Protection provided training to Planning staff on several
 mapping tools related to sea rise, flood exposure, storm surge, and coastal resiliency. These
 mapping tools will be of great benefit to the planners when the Comprehensive Plan is updated to
 meet the 2015 approved state statute requiring local governments to assess infrastructure and
 critical facilities that are prone to hazardous events.
- Staff met with the applicant of Ormond Central to discuss several issues related to the proposed development at the intersection of W. Granada and Old Kings Road.
- The Planning Director attended the Technical Coordinating Committee meeting of the Transportation Planning Organization. Presentations of interest included the Pedestrian crash statistics and the updates to the Florida Greenways and Trail System (FGTS) Plan. SR40 and the US1 trail were upgraded to a Priority Trail making them eligible for SunTrail funding.
