Dear Ms. Towey:

We have enclosed performance for the City of Ormond Beach Firefighters' Pension Trust Fund for the period ending March 31, 2017. Relevant indices have been included for comparison purposes.

At the March FOMC meeting, the Committee voted to raise the fed funds rate range by 25 basis points from 0.50%-0.75% to 0.75%-1.00%. The Fed was pleased with the gains in the labor market and inflation we have seen this year as the change in Nonfarm payrolls was above expectations and measures of inflation have moved toward their 2% target. The rate hike was widely expected, but the markets were relieved the FOMC statement and projections of future hikes were not as bearish as some had feared. Additionally, the markets regarded the new administration's inability to repeal and replace the Affordable Care Act as a sign the President's economic agenda may be more difficult to enact than previously believed, which caused yields to move off of the peaks they had reached earlier in March.

The 10-year Treasury yield started the year at 2.44%, reached an intra-day peak of 2.63% prior to the March FOMC rate decision, but it declined from there and finished the quarter at 2.39%. The 2-year yield increased 6 basis points to 1.25% while the yield of the 30-year Treasury declined 5 basis points to 3.02%. These moves caused the 2-30 year yield spread to flatten to 177 basis points.

With the modest decline in longer term rates, the bond market experienced a positive return of 0.82% for the Bloomberg Barclays Aggregate Index and a return on the Bloomberg Barclays Intermediate Government Credit Index of 0.78% this quarter. Spread product was generally a positive contributor this quarter as three of the four spread sectors delivered positive excess return. The agency sector was the leader this quarter with 60 basis points of excess return. The corporate sector and asset-backed securities sector followed with 38 basis points and 22 basis points of excess return, respectively. The mortgage-backed securities sector was the laggard with -17 basis points of excess return. Thus, the Bloomberg Barclays Aggregate Index had 11 basis points of excess return this quarter.

We shortened our duration and are now only marginally longer than the benchmark index. However, we maintained our "barbell" positioning in anticipation of a flatter yield curve.
