Community Development

Planning

- Planning staff conducted a discussion item with the Historic Landmark Preservation Board regarding the fees associated with removal of property from the Local Landmark List. The Board discussed the fees for both designation and removal of properties from the Local Landmark List. The Board stated the number of removals since the landmark list was created was small and is not a significant cost impact to the City over all of those years. The Board recommended charging a fee of \$200 to get onto the Local Landmark List and a fee of \$200 fee to be removed from the Local Landmark List.
- Beginning March 2, 2018, the contractor for the Granada Pointe project will close Tomoka Avenue between Bennett Lane and West Granada Boulevard. This closure will allow the improvements to re-align and upgrade the roadway and intersection, including the installation of a traffic signal.
- Staff has performed advertising of a Special Exception at 160 Business Center Drive to allow the
 re-establishment of a child care facility which previously existed on this property. The current
 application proposes to use the property as it exists today and no site modifications or additional
 building expansion is proposed.

Building Inspections, Permitting & Licensing

Development Services

- The Site Plan Review Committee (SPRC) conducted a final inspection at the McDonald's at 100 South Nova Road associated with the drive-thru site modifications.
- SPRC staff reviewed a concept plan at 88 South Atlantic Avenue, the former Julian's restaurant.
 The concept plan proposes to demolish the existing building and redevelop the property with an 8.950 square foot building and associated site improvements.
- SPRC staff reviewed a concept plan at 825 Hull Road which is currently vacant. The project proposes an RV and boat storage facility with associated site improvements.

Economic Development/Airport

Economic Development

- Ormond Crossings
 - Staff meets weekly with the consultants representing Security First Managers office project planned for Tract 18 in the Ormond Crossings Commerce Park. The site plan was approved by the SPRC and land clearing has begun. The first plat in the Ormond Crossings

- development was approved by the Planning Board and City Commission for the Security First Managers office project.
- FDOT has provided their comments on the Security First Managers traffic study. Staff is
 working to make appropriate responses to FDOT's US1 traffic mitigation measures. Staff met
 with the Security First team to prepare agreements for the process to construct the extension
 of utilities that will serve the project. The Agreement will be submitted to the Commission in
 March or April.
- The building plans are under review and Security First Managers consultants are working with staff for final approval.
- A groundbreaking event is schedule at the Security First Managers site at Ormond Crossings on March 7, 5 pm-7 pm. A more detailed itinerary is forthcoming.

Airport Business Park

- Staff has prepared a new Growth Assistance Program application for Concentrated Aloe as
 the company was delayed in the construction of their manufacturing plant on Lot 2 in the
 Business Park and has requested staff to process its formerly approved Property Tax
 Reimbursement application. The GAP Agreement is scheduled for review by the Commission
 in April.
- Staff is preparing a revision to the Prime Global Group, Inc., GAP that will be presented to the Commission on March 6.
- Staff prepared 2 applications to the Florida Department of Economic Opportunity's Florida Job Growth Grant Fund. One is for the construction of Business Park Way, which will connect the northerly section of the Airport Business Park to Pineland Trail. This grant application also covers construction cost for proposed roadways within the Southwest Quad at the Airport. A second grant application was prepared for the water and sewer line extensions for the north US1 area of the City, which will benefit Ormond Crossings and other development projects in the US1 corridor. The State has announced funding of several projects. The City's legislative lobbyist is contacting state officials to discuss the City's need for funding of the grant applications.
- Ormond Beach Chamber, Main Street, Team Volusia, and Volusia County
 - Staff attended the Ormond Chamber Economic Prosperity meeting and presented the City's economic development activities.
- Prospective Business Attraction/Retention/Expansion
 - Staff continues the ongoing outreach to Ormond Beach businesses to assist with expansion opportunities.

Airport Operation and Development

- Framing of the main hangar door on the large Sunrise Aviation hangar adjacent to Gate 9 has been completed. Metal sheathing to be installed next will complete the door and the overall repairs.
- Staff has been advised that a Joint Participation Agreement (JPA) with the FDOT was executed by FDOT this week. The JPA will provide state funding for a comprehensive obstruction mitigation project at the airport. The JPA was approved by the City Commission at their meeting on February 6.
- Work continued this week to replace certain light poles in the Ormond Beach Sports Complex. Staff has coordinated with the FAA and the air traffic control tower to ensure that airport users are aware of this work which involves use of a crane located approximately ½ mile northwest of the approach area for Runway 17.
- Staff is in receipt of the first draft of the State of Florida's Pavement Classification Number report
 for the airport. The FDOT Aviation and Spaceports Office is providing statewide Pavement
 Classification Number Development (PCND) evaluations for runway pavements at Florida's
 public-use airports. The state's consultant for this project, CDM Smith, Inc., retained RDM
 International, Inc., to perform the PCN evaluation at the Ormond Beach airport. Runway 8-26 and
 Runway 17-35 were both included in this evaluation. Staff will review the draft report with the

City's airport consultants and provide commentary to FDOT for use in composing the final draft of the report.

- Staff previously reported that the FDOT Aviation and Spaceports Office (ASO) inspected the airport on February 8. Staff received an inspection acknowledgment from FDOT this week indicating that the renewed Airport License has been issued and will be forwarded to the City.
- Staff met this week to review preliminary designs and locations for new directory signage at the airport.

 reclaimed water main on Seminole Drive; letters are being mailed to property owners on
 South Halifax Drive, Riverside Drive, Riverside Circle, Bosarvey Circle, Willis Drive,
 Fluhart Drive, and Pine Road that service is available and they may connect to the City's
 system.

 - Effluent Outfall Replacement A pre-construction meeting was held; a Notice to Proceed was issued for the first week of March.

- Downtown Light Replacement The bid award is scheduled for the March 6 City Commission meeting.
- Storm and Sewer Lining Bid was awarded at the February 20 City Commission meeting, along with the Work Authorization for first year of work.
- CDBG Streetlight Replacement The project was advertised on February 11, a pre-bid meeting is scheduled on February 28, with bid opening on March 15.
- CDBG Cassen Park Fire Hydrant Staff is finalizing the quote package to solicit written proposals.
- A1A Manhole Repair Bids were opened on February 6 and are under review.
- City Hall/SONC HVAC Repairs City Commission approved the project for bidding at the January 16 City Commission meeting and the project was advertised. A pre-bid meeting was held on February 1; bids are due on February 21.
- 2018 Road Rehabilitation-Resurfacing This project will be presented to the City Commission concurrently with the below pavement preservation project for approval to advertise for bids.
- 2018 Road Rehabilitation Pavement Preservation Staff is working with Purchasing to utilize a competitively bid contract from Largo for this work.
- Forest Hills Connector Trail Plans and specifications are on the March 6 City Commission agenda for disposition for bidding. Project is scheduled to be advertised March 11
- Water Plant Upgrades Staff anticipates receiving the 90% bid documents the beginning of March.

- Deer Creek Reclaimed Water Contracts were received back from the contractor and have been sent to Legal for final review and execution. A pre-construction meeting will be scheduled once contracts are fully executed.
- WTP Sludge Residuals Facility Improvements Staff received final plans and has scheduled this for City Commission approval to bid at the March 6 meeting.

Design Projects:

- North US1 Water Main Improvements Staff has completed modeling for improvements to improve reliability to the single water main that extends along north US1 to the City limits. Staff has identified a two phase approach. Phase 1 will be to loop the main that feeds Security First in Ormond Crossings which will provide a redundant loop for US1 along the length, and will also bolster water pressures needed for the fire flow demand to the proposed four story Security First building. The design engineer for the water extension to Security First will add the additional work to their contract to allow the loop to be installed in time to meet building schedule needs of Security First. Phase 2 will extend a new 12-inch water main from Airport Road South along US1 to "Double Barrel" the existing single 12-inch water main. Staff is applying to the State for an Economic Development Grant that, if approved, will pay for the construction cost for the water main improvements (\$2.05 million).
- Ormond Crossings Utility Extensions Final design has been completed and staff is
 working on the agreement for construction reimbursement. Security First, in order to get
 the water to the site, has offered to up-front the construction cost for the utility extensions
 to the site on the condition that the City agrees to reimburse them for the cost. Staff is
 coordinating the necessary agreement to allow this to happen.
- West Ormond Community Center At the Strategic Issues Workshop, the City Commission stated that the cost for the West Ormond Community Center was too expensive at this time and instead directed the City Manager to pursue a feasibility study for construction of an Emergency Operations Center (EOC) somewhere to be determined within the City. Staff will include this in the upcoming CIP.
- Cassen Park Public Dock-Fishing Pier Repair and Breakwater Extension –The FIND Agreement was approved at the January 2 City Commission meeting along with the Work Authorization for the design for the fishing pier repairs along the south side of the bridge and expanding the breakwater proposed with the public dock project. The consultant has submitted a request for a permit exemption from FDEP for the fishing pier repairs. If that is approved, they will then submit to FIND for an emergency disaster repair grant for 50% of the cost of the repair of the fishing pier.
- WWTP Sludge Dewatering Improvements Staff received a preliminary design report
 that compared centrifuge technology to screw press technology for dewatering sludge at
 the WWTP. Based on the report, it was decided that centrifuges provided more flow and
 were best suited to meet operational requirements at the WWTP. The consultant is
 proceeding with final design.
- Downtown Stormwater Phase 2 Consultant has revised landscape and hardscape plans per review by City staff and Ormond Mainstreet.
- Fleming Ave Stormdrain Improvements A FEMA HMGP Phase I design/engineering grant is fully executed. The preliminary design consultant is preparing a scope of work for the final design. This project was identified for design in FY 2018-19 in the 5 year CIP
- Wilmette Avenue Pumping A FEMA HMGP Phase I engineering/design grant has been approved for this project and is under review by staff.
- Laurel Creek Stream Gauges OptiRTC has provided a proposal to the City for additional stream level monitoring. Staff is reviewing this proposal that would allow the OPTI desktop to monitor these additional level gauges alongside the level at the Bennett Lane pump station.
- Cassen Park Improvements (Paving and Restroom Replacement) Staff will look to apply for an HMGP grant which would pay 75% of the project total construction cost. However, after talking with Florida DEM, park projects do not normally meet HMGP benefit cost requirements and thus may not be an eligible project for the HMGP program.

- Volusia County Health Department Staff is in communication with the VCHD regarding lead and copper data which was submitted the Department. Clarification was necessary to ensure completeness. Also, staff submitted a revision to the Total Coliform (TC) sampling plan. The revision updated the TC sampling locations utilized by City staff.
- Industrial Pretreatment Program Staff is preparing the Annual Industrial Pretreatment report for submittal to the FDEP. The report provides insight into the activities of the program for the 2017 calendar year.
- Florida Tier II Chemical Inventory Report Staff has begun compiling the information to submit the Chemical Inventory Report to the FDEP. The report provides information to first responders in case of an emergency at one of the City's facilities which contain hazardous materials and chemical.

Support Services/City Clerk
